

GUIDELINES FOR THE REGISTRATION OF FOREIGN GRADUATES WITH MEDICAL LABORATORY SCIENCE COUNCIL OF NIGERIA.

Introduction: Foreign graduates in this context refer to qualified Medical Laboratory Scientists, Technicians and Assistants herein after abbreviated as MLS, MLT and MLA respectively trained outside Nigeria. The candidate seeking Council registration into any of the above Cadres should satisfy the following criteria.

(A) Application for Registration

- i. Applicant shall complete an application form downloaded from Council website: www.mlscn.gov.ng.
- ii. The cadre he/she is seeking registration for shall be stated (i.e. MLS/MLT/MLA).
- iii. Possess minimum O' level subjects requirement prescribed for such Cadre at not more than 2 sittings (5 credits in English Language, Mathematics, Biology, Chemistry & Physics for MLS; 4 credits in English Language, Mathematics, Biology, Chemistry and at least a pass in Physics for MLT; 3 O' level credits including Biology, English and any other subject plus at least a pass in Chemistry, Physics and Mathematics for MLA.)
- iv. Attach qualification(s) obtained and academic transcript to support his/her application.
- v. Request Federal Ministry of Education to evaluate the Degree, Diploma or Certificate obtained for such cadre as well as foreign O' level certificate and forward directly to Council.
- vi. Request his/her Institution to forward directly to Council hard copies of transcript and training Curriculum in official seal and stamp.
- vii. Pay application fee of Ten Thousand Naira (₦10, 000.00) only to the Medical Laboratory Science Council of Nigeria and development levy of Eight Thousand Naira (₦8, 000.00).

(B) Verification of Certificates and transcripts

- i. All Certificates and transcripts presented by the applicant shall be verified.
- ii. If deficient, the candidate shall be asked to remedy the deficiency before proceeding to the next stage.
- iii. Certificates and transcripts not written in English Language shall be required to be translated to English Language at cost to be borne by the applicant.
- iv. Foreign O' level results must be sent for evaluation to the Fed. Min. of Education (FMoE) by the candidate and the evaluation report sent directly to Council.
- v. All Certificates and transcripts not clearly understood shall be sent for evaluation to determine its equivalence at the expense of the applicant.
- vi. Applicants whose training curriculum were grossly deficient with Nigerian Equivalence will undertake and pass the deficient Courses in an approved institution to qualify for internship and assessment Examination

(C) Internship/Laboratory Posting

- i. All foreign graduates requiring registration with the Council shall undergo 12 months internship in Council approved Laboratory to acquaint them with the procedures obtainable in our locality.
- ii. The internship shall be done under the supervision of qualified and licensed Medical Laboratory Scientists using Council log book.
- iii. The Logbook duly signed by the appropriate officers of the institution where internship was done shall be submitted to Council as a condition for eligibility for the assessment examination.

(D) Council Assessment Examination

- i. The applicants for Council registration shall sit for assessment examination which shall be organized once a year.
- ii. The examination will be specific for each cadre and shall comprise of Multiple Choice Questions, Practical and Oral/Viva. The Examination shall include the following:-

1. Multiple choice questions shall be practical-oriented covering all disciplines of Medical Laboratory Science.
2. Practical papers which shall include examination of spots/specimens.
3. Oral or Viva covering all disciplines of Medical Laboratory Science including log book assessment.

The examination fee is as follows:-

(a) Associate Registration (Nigerians)	₦50, 000.00
(b) Associate Registration (Non Nigerians)	₦75, 000.00
(c) MLT/MLA Registration (Nigerians)	₦25, 000.00
(d) MLT/MLA Registration (Non Nigerians)	₦50, 000.00

Successful candidates shall proceed for Council's registration while the unsuccessful candidates shall re-sit the examination in the next available opportunity and pay only the examination fee.

Candidates who fail 3 consecutive times shall be barred from taking the exam until he/she undergoes 12 months remedial course.

(E) CATEGORIES OF REGISTRATION

- (i) **MLS Provisional Registration:** shall be granted to candidates with foreign qualification equivalent to BMLS/Associate. This will enable them to undergo the 12 months Internship in an approved Laboratory prior to the qualifying examination.
- (ii) **MLS Full Registration:** shall be granted to candidates after passing the qualifying examination.
- (iii) **MLT/MLA Registration:** Full registration is granted to this cadre after passing the qualifying examination which enables them to seek for employment but not to register premises in their name.

(iv) LICENCE/ANNUAL REGISTRATION RENEWAL:

- (a) Provisional licence is not renewable unless with cogent reason.
- (b) All categories of full registrations shall pay prescribed fees for issuance of practising Annual licence/Registration which is renewable yearly.
